## **THE CONNECTICUT TECHNOLOGY COUNCIL HOSTS SECOND ANNUAL INNOVATION PIPELINE ACCELERATOR AWARDS**

### **EMERGING TECHNOLOGY COMPANIES HONORED FOR THEIR POTENTIAL AND ACCOMPLISHMENTS**

#### **Connecticut Technology Companies Present Innovative Ideas in Poster Fair**

SEPTEMBER 17, 2008: New Haven, CT — Almost 400 entrepreneurs, investors, and service providers gathered on Tuesday, September 16 at The Dolce Norwalk Center for Innovation & Leadership for the Innovation Pipeline 2008 Companies to Watch Awards event, a celebration of the 100 most promising early stage technology companies in the state.

Tuesday's event honored emerging technology companies considered to have some of the best potential for future success. A key aspect of the evening's program included a poster fair where start-up firms could present their business concept. 100 companies presented their ideas.

The Innovation Pipeline Accelerator, a virtual incubator managed by the Connecticut Technology Council, with major funding from the State of Connecticut's Cluster Initiative, includes a number of efforts to support young high tech firms in the state to grow quickly.

Throughout the year volunteers associated with the Connecticut Technology Council select the technology companies most likely to grow quickly and worked with them through the program ([www.ctipa.org](http://www.ctipa.org)). The Innovation Pipeline Accelerator provides training, support from selected service providers and introductions to customers, peers and funding sources and mentors.

The awards event and the Innovation Pipeline Accelerator programs are sponsored by the State of Connecticut - DECD, Cantor Colburn LLC, CT Innovations, Edwards Angell Palmer and Dodge LLC, eTouches, HR411, Tyler Cooper LLC, Open Solutions, Fiondella Milone and LaSaracina, UHY LLP, VBrick and Wellstone Insurance.

Companies may remain in the program as long as the program adds value to their business and the company continues down the path towards success. Some of the more advanced IPA companies will be selected to receive extra assistance in the FastTrack Program that provides more personalized services.

Modeled after the best-of-breed examples from innovation centers, angel groups and incubators worldwide, the FastTrack program assists any Connecticut technology company with the potential to rapidly scale into market and financial leadership.
